



NON-RESIDENT TUITION STUDENT STATEMENT OF BEHAVIOR

Statement of Satisfactory Behavior and Academic Performance

Conditions of Enrollment As the parent/guardian of a student being enrolled as a tuition student, I understand that I must submit evidence of satisfactory behavior and academic performance as a condition of enrollment.

Enrollment is at the sole discretion of the Bloomfield Hills Schools Board of Education. Prior to enrollment, the following must be provided to meet the terms of satisfactory behavior and academic performance:

- a) Three previous years of end of year report cards showing citizenship grade and current Grade Point Average (GPA). High School students must provide current transcript and report cards (Cumulative GPA of 2.0 or better. Other grades must be passing, satisfactory, acceptable or similar).
- b) Letter from previous school stating that student was in good standing for behavior. If there is an incident of concern, it is outlined in the letter and signed by an administrator.
- c) Individual Educational Plan (IEP) and IEP Progress Reports indicating progress toward goals and objectives - if one exists.
- d) 504 Plan - if one exists.

Conditions of Continued Enrollment As the parent/guardian of a student being enrolled under the tuition program, I understand that the tuition enrollment may be terminated if satisfactory behavior and academic performance are not maintained. Continued enrollment is at the sole discretion of the Bloomfield Hills Schools Board of Education. The conditions of continued enrollment in the Bloomfield Hills Schools are outlined below:

- a) Maintain a 2.0 GPA or above
- b) Maintain satisfactory behavior performance, including standards outlined in the Bloomfield Hills Schools Uniform Code of Student Conduct
- c) Any misleading, omitted, or incorrect information may be cause for immediate termination of enrollment
- d) Parent agrees to provide transportation for student. All tuition students are eligible to apply for a parking pass their junior and senior years. Parking passes are not automatically issued to non-resident tuition students.

Parent/Guardian Certification By signing below I, the parent or legal guardian of the above named tuition student, certify that: my child meets the academic requirements as stated above and that my child meets the behavioral requirements and any and all behavioral issues or concerns have been identified and discussed with enrollment staff and/or appropriate building administrators. I understand the non-resident tuition enrollment may be terminated at the sole discretion of the Bloomfield Hills Schools Board of Education if satisfactory behavior and/or academic performance are not maintained.

In the event that the Board of Education determines that enrollment will be terminated, the parent/guardian shall receive written notice of the termination. There are no tuition payment refunds for students who are exited from the district either by the Board of Education or by the discretion of the parent. If tuition is not paid in full at the time of the student exiting the district, I understand that I am responsible for any outstanding tuition payments due.
